The revised Ritual, Job's Daughters Handbook, and the Proficiency Lessons are now available on our website, and it's available for **FREE**! Please note that FUTURE versions will likely not be available for free.

You may start using the new Ritual & Proficiency Lessons now. However, beginning on **April 1, 2025**, **ALL Bethels must be using the new Ritual & Proficiency Lessons.**
