## INSTRUCTIONS

When a Bethel member desires to withdraw from the Order or desires to transfer her membership for any reason, the Guardian Secretary, by authority of the Executive Bethel Guardian Council, will issue to the Daughter a Demit on this form. It shall be completely filled in and signed by the Bethel Guardian and the Guardian Secretary under the Bethel seal. The member should be instructed to sign the form.

If, within six months, the Daughter applies to another Bethel, the Demit (complete form) shall be attached to an Application for Membership by Affiliation (Form 131). If the Daughter is elected to membership, the Guardian Secretary of the Bethel in which the Daughter is elected, shall complete the second, third and fourth sections of the form and mail them to those designated. If the application is to another Bethel in the same State, Province, Territory or Country, or to a Bethel not under Grand Guardian Council jurisdiction, the fourth section is unnecessary and may be destroyed. The first section shall be permanently attached to the Application for Membership by Affiliation and retained in the Bethel files.
