## **Initiate:**

A new applicant

Please mark one of the following for each initiate on the Form 110:

- a. Masonic Relationship – A member joining on a familial Masonic Relationship
- b. Sponsorship – A member who lacks a familial Masonic Relationship and who is sponsored by a Majority Member and a Master Mason

## **Reinstated:**

- a. Reinstatement from suspension - a member who has been suspended from the Order not more than one (1) year for non-payment of dues may be reinstated by paying all unpaid dues to the date of suspension.
- b. Reinstatement from expulsion – a member who has been expelled from the Order may apply for reinstatement three (3) months or more after final action is taken in her case, by written application to the Executive Members of the BGC of the Bethel from which she was expelled (SOP-Bethel 3.1)

# **Explanation of Increases in membership cont. :** Daughters who have joined the Bethel during the last calendar year (January 1 - December 31)

## **Affiliate:**

A member who has demitted from a Bethel and wishes to join another

## **Merged:**

Members from Bethels that have been merged into one Bethel

## **Dual Member:**

A Daughter wishing to join another Bethel while maintaining membership in her original Bethel.  
Dues are payable to **EACH** Bethel (B-Bethel 1)

# **Explanation of Decreases in membership:**

**Daughters who have left the Bethel during the last calendar year (January 1 - December 31)**

## **Majority Member:**

- a. A member who is in good standing upon becoming twenty (20) years of age or married or pregnant under that age or identifies as a male.
- b. A member who has demitted from the Order and who has passed the age of twenty (20) or who has married or becomes pregnant before twenty (20), or who identifies as male may be reinstated as a Majority Member (SOP-SGC-12). The member must be recorded as reinstated on the Form 110.

## **Demitted:**

- a. A member who is in good standing who desires to withdraw from the Order
- b. A member who desires to transfer her membership for any reason to another Bethel

## **Resignation:**

A member who has resigned her membership from the Bethel. A Daughter who has resigned may apply to a Bethel to become a member – the process is the same as one who has never been a member (Bylaws-Bethel 2)

# **Explanation of Decreases in membership cont.:**

**Daughters who have left the Bethel during the last calendar year (January 1 - December 31)**

## **Suspended:**

- a. A member suspended for non-payment of dues
  - a. Member may be reinstated after paying all unpaid dues to the date of the suspension
- b. A member suspended for insubordination or the retention of money or property of the Bethel
  - a. Suspension shall not exceed a period of six (6) months. After that period, the suspended member shall be reinstated or expelled (SOP-Bethel-3 Discipline)

## **Expulsion:**

A member expelled for flagrant behavior or deliberate disobedience to the laws of the order

- An expelled member may apply for reinstatement three (3) months or more after final action is taken in her case (SOP-Bethel-3 Discipline)

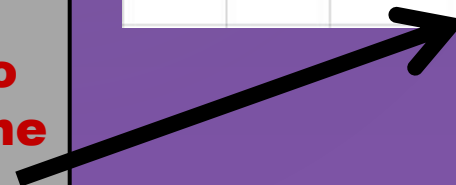

In the USA & Canada: Bethels under Supreme will pay to the SGC \$15.58 + \$39.29 for a total of **\$54.87** per member plus \$16.81 for each member initiated during 2025.

In the USA & Canada: GGCs will pay to the SGC \$11.70 + 39.29 for a total of **\$50.99** per member plus \$5.02 for each member initiated during 2025. GGCs keep 25% of the Initiation Fees and Annual Dues.

Please note: Bethels in Canada, Australia, the Philippines, and Brazil will use the exchange rate issued by the SGC as of 12/31/25. This rate applies to the Annual Dues and Initiation Fees **BUT NOT** the Insurance Fees.

## Things to note:

- Bethels under Supreme will pay the **Annual Dues (\$15.58)** and the **Initiation fee (\$16.81)** to the SGC
- Bethels under a GGC will pay the **Annual Dues (\$15.58)** and the **Initiation fee (\$6.69)** to the GGC
- ALL Bethels in the US and CAN pay the **Insurance fee (\$39.29)** for **ALL** members
- Dual members pay dues to **BOTH** Bethels & **BOTH** Bethels will pay the **Annual Dues** to the GGC/SGC. The insurance fee is also due to the SGC from **BOTH** Bethels
