There will be two (2) Arts & Crafts Packets this year.

- Packet 1 is for those Daughters attending Supreme Session - In Person
- Packet 2 will be for those Daughters who will attend Supreme Session -Virtual/Remote

Daughters attending in person cannot bring items for Arts & Crafts Competitions for other Daughters who are not attending In Person. Those not attending In Person will register their Arts and Crafts Competitions using the Virtual Packet 2. Each packet has its own rules.

2026 Supreme Arts & Crafts General Rules

Please read the general rules for the competition as well as the specific guidelines for each category. If you have any questions, please contact the Co-Chairs by email at artscrafts@jdint.org.

A Daughter's age as of July 20, 2026, shall determine which age group the Daughter should enter.

Arts & Crafts categories will be judged under the specific age groups as follows:

- Δ 10-12 years old
- Δ 13-15 years old
- Δ 16-17 years old
- Δ 18-19 years old

Please note that the Promotion Category will NOT be broken down into age groups.

Final Registration Deadline for all entries is June 1, 2026.

No entries will be accepted after this date!

QUALIFICATIONS: Job's Daughters submitting entries must be in good standing with Job's Daughters International (JDI) as of July 20, 2026. The contestant must have made the entry during the current Supreme Guardian Council year: August 2025 through July 2026.

ENTRIES: How to enter Arts & Crafts items for judging

Registered entries need to be hand-delivered to the Arts & Crafts area/room at Supreme Session. Hand delivered entries are to be submitted at the University Plaza Hotel & Convention Center, Springfield, Missouri starting on Monday, July 20, 2026, between 9:00 am and 3:00 pm, but no later than Tuesday, July 21, 2026, between 9:00 am and 12:00 pm. Please check the actual Supreme Session information at the hotel for any adjustments to entry times. No late entries will be accepted unless caused by a travel emergency.

Please note the following Additional Information:

- A contestant may enter only 1 (one) item per Category Division. The contestant must have registered as IN PERSON by the registration deadline. Multiple entries by the same contestant within the same Category Division will not be allowed.
- The name of the person responsible for picking up the entry must be clearly stated.
- The entry must be as described on the registration form; substitutions will not be accepted.
- Contestants are responsible for storing their own packing material. Packing material left in the competition room will be discarded.

PREPARE ENTRIES: A sealed envelope shall be attached to each entry with the following:

Outside of the envelope shall contain:

- Daughters Age
- Category

Inside of the envelope shall contain:

- Copy of the registration form

CATEGORIES: Each contestant determines in which Category and Division she wishes her entry to be judged. However, the Arts and Crafts Committee reserves the right to adjust categories. Please read the rules and guidelines for each category. The Supreme Arts and Crafts Committee reserves the right to disqualify an entry, at its discretion, based on content in keeping with the rules and regulations of Job's Daughters International (JDI).

JUDGING: Judging will be Wednesday, July 22, 2026, from 9:00 am – 5:00 pm. No viewing of entries will be allowed before or during the judging.

Judging will be based on the following, as applicable: originality, design, artistry, presentation/layout, degree of difficulty, craftsmanship, neatness, and finishing. Completed judging score sheets will be given to the contestants after the Awards Luncheon on Friday. The decision of the judges is final.

VIEWING: The competition room will be open for viewing Thursday, July 23rd, 2026, from 9:00 am to 3:00 pm and Friday, July 24th, 2026, from 9:00 am to 11:00 am. All entries must remain in the competition room during this time.

PICK-UP: Entries must be claimed on Friday, July 24th, 2026, no later than 4:00 pm unless other arrangements have been made with the Arts and Crafts Committee Chairmen.

Category Rules

- Category includes all forms used in promotion of Job's Daughters (i.e. story board, video, web design, T-shirt design, button, postcard, etc.)
- Must be created entirely by the Daughter submitting the entry.
- May not mention the Daughter's name or Bethel number.
- Entry may not have been previously submitted to a Supreme Arts & Crafts contest.
- Only one (1) entry per Daughter.
- Daughter's name should not appear on the entry itself.

Division B – Quilts

Category Rules

- Category includes all forms of quilting (i.e. applique', patched/pieced work, etc.)
- Must be created entirely by the Daughter submitting the entry.
- May be made by hand or machine, or a combination of both methods. However, it must be noted on the entry form how the entry was made (i.e. hand or machine).
- Must not contain any reference to a Daughter's name or Bethel number.
- Entry may not have been previously submitted to a Supreme Arts & Crafts contest.
- Only one (1) entry per Daughter.
- Daughter's name should not appear on the entry itself.

- May be a kit, leaflet, or original needlework design. However, it must be noted on the entry form how the entry was made (i.e. kit or original).
- Must not contain any reference to a Daughter's name or Bethel number.
- Entry may not have been previously submitted to a Supreme Arts & Crafts contest.
- Only one (1) entry per Daughter.
- Daughter's name should not appear on the entry itself.

- Must be created entirely by the Daughter submitting the entry.
- May be a kit or an original design. However, it must be noted on the entry form how the entry was made (i.e. kit or original).
- Must not contain any reference to a Daughter's name or Bethel number.
- Entry may not have been previously submitted to a Supreme Arts & Crafts contest.
- Only one (1) entry per Daughter.
- Daughter's name should not appear on the entry itself.

Division F – Photography**Category 1: Portrait**

A photograph of a person. One depicting only the face and /or head and shoulders.

Category 2: Still Life

A photograph of an arrangement of objects, typically including fruit and/or flowers and objects contrasting with these in texture, such as bowls and glassware.

Category 3: Candid Shot

The definition of candid is informal or natural (any subject).

Category 4: Scenery

A picturesque view or landscape.

Category 5: Other

Any photo that doesn't fit in the other 4 categories.

Category Rules

- Must be taken by the Daughter submitting the entry.
- May be developed by the Daughter or professionally.
- Must not contain any reference to a Daughter's name or Bethel number.
- Entry may not have been previously submitted to a Supreme Arts & Crafts contest.
- Only one (1) entry per Daughter per category.
- Daughter's name should not appear on the entry itself

Division G – Painting

Category 1: Oil or Acrylic

Category Rules

- Must be an original painting created entirely by the Daughter submitting the entry.
- Please limit the size to no larger than 16x24 inches.
- Must mention on the entry form the medium used to create the painting (i.e. oil, watercolor, acrylic, or mixed media).
- Must not contain any reference to a Daughter's name or Bethel number.
- Entry may not have been previously submitted to a Supreme Arts & Crafts contest.
- Only one (1) entry per Daughter per category.
- Daughter's name should not appear on the entry itself.

Division H – Drawing

Category 1: Pencil/Colored Pencil

Category Rules

- Must be drawn or sketched entirely by the Daughter submitting the entry.
- Please limit the size to no larger than 16x24 inches.
- Should be either matted and/or framed or have a sturdy adhered backing.
- Must not contain any reference to a Daughter's name or Bethel number.
- Entry may not have been previously submitted to a Supreme Arts & Crafts contest.
- Only one (1) entry per Daughter.
- Daughter's name should not appear on the entry itself.

Division I – Computer Generated Art**Category Rules**

- Must be designed entirely by the Daughter submitting the entry.
- Must be created on a computer using any computer program. However, it must be noted on the entry form what program was used (i.e. Publisher, Photoshop, etc.)
- Must not contain any reference to a Daughter's name or Bethel number.
- Entry may not have been previously submitted to a Supreme Arts & Crafts contest.
- Only one (1) entry per Daughter.
- Daughter's name should not appear on the entry itself.

- Must not contain any reference to a Daughter's name or Bethel number.
- Entry may not have been previously submitted to a Supreme Arts & Crafts contest.
- Only one (1) entry per Daughter.
- Daughter's name should not appear on the entry itself.
