At that time the Bethel Guardian will provide information regarding who will be paying for the medallion. That fee is due by June 1 to the Supreme Office, payable to JDI.

## Lily of the Valley Award Nomination Form

1. The purpose of this award is to pay special honor to those Daughters and Majority Members who are between the ages of eighteen (18) and twenty-four (24) years of age, who have continued to show active support of their Bethel and JDI by unselfish efforts and commitment.
2. The Daughter must be nominated for the Award by a Bethel Guardian Council without her knowledge. Other Daughters may recommend her nomination to the Executive Bethel Guardian Council.
3. If the nominee is a PHQ, she must have completed her term as HQ at least two (2) years prior to her nomination to receive the Lily of the Valley Award. If a nominee has served multiple terms as Honored Queen her first completed term must be at least two years prior to nomination.
4. The Bethel Guardian must complete and see that the Lily of the Valley Nomination form and packet are received by the Committee Chairman on or before April 15<sup>th</sup>.
5. The nomination form shall include specific examples of outstanding service to the Bethel.
6. In addition to the nomination form, recommendations in writing from four (4) responsible adults not related to the nominee, who have first-hand knowledge of her contributions to the Bethel must be included. These letters should also include specific examples of her outstanding service. Bethels Under Supreme must include one (1) recommendation from either the Supreme Deputy or Assisting Supreme Deputy. The SD or ASD letter may be sent in separately from the rest of the packet.
7. Nomination may be by either the nominee's home Bethel or a Bethel to which she has contributed outstanding service to merit the nomination.
8. The Committee Chair shall notify the recipient and the BGC nominating her of her selection by May 15<sup>th</sup>. In addition, at this time the BGC will provide the information of who will be paying for the medallion. Payment is due to the Supreme Office by June 1<sup>st</sup>, payable to JDI. If the BGC wishes to keep this selection a surprise from the recipient, they must be able to tell the Committee Chair whether the recipient will be in attendance at the Supreme Session Formal Opening Ceremony prior to June 1<sup>st</sup>.
9. The Supreme Bethel Officers may confer the award at the Annual Session of the SGC during the Supreme Bethel Meeting, or, if the recipient is unable to attend the Annual Session of the SGC, the Bethel that nominated her may confer the award at a regular Bethel meeting, jurisdictional or open event.
10. At the time of the ceremony, the recipient shall receive a stem of lily of the valley, a certificate and a medallion engraved with her jurisdiction on the reverse side.
