How can I get the “Ignite Your Imagination” for HIKE pin?

Please request a pin on the order form sent with this letter. Pins are \$5.00. Please do not send cash. Only check or money order in US dollars are accepted (Send any funds for Canada to HIKE Canada to their Board in Canadian Currency). 
