 - (3) Collaborate with all relevant committees of the SGC, GGCs, JGCs, and Bethels under Supreme to develop, strengthen, and expand the Bee Program in all jurisdictions of Job's Daughters International.
 - (4) Oversee and administer all Bee-related awards, recognitions, and initiatives of Job's Daughters International.
 - (5) Develop guidelines, resources, and best practices to ensure consistent and sustainable implementation of the Bee Program.
 - (6) Foster, promote, and encourage the implementation of the Bee Program in every Bethel, Grand Guardian Council, and Jurisdiction of Job's Daughters International, both present and future.
- (e) Records
 - (1) The Chairman shall keep a permanent file which shall be turned over to her successor.

NOW READS:

- (a) The flag is carried at a sixty (60) degree angle by holding the right hand around the staff with the thumb pointing upward toward the Flag. The right hand is placed on the staff at a height of and on a level with the left shoulder, elbow relaxed. The left hand is at the waistline, hand around the staff, with the base of the hand resting against the left hip. The Flag should never be allowed to touch anything beneath it. The eagle at the top of the staff shall face forward, including when placed in the flag holder in the East.

- (a) The flag is carried at a sixty (60) degree angle by tilting the staff forward in a slight angle. holding the right hand around the staff with the thumb pointing upward toward the Flag. The left hand is at the waistline, hand around the staff, with the base of the hand resting against the left hip. The Flag should never be allowed to touch anything beneath it. The flag should never be dipped to any person or thing. The eagle at the top of the staff shall face forward, including when placed in the flag holder in the East.

REASON FOR CHANGE:

This amendment aligns our flag protocol with that of the US Flag Code. The Flag Protocol has not been updated in a number of years, and there is often confusion over what the governing requirements of carrying the United States of America Flag. Respect to the USA National Emblem includes not showing deference to any other emblem - no matter which country's emblem is being carried and matches many parade requirements for the national emblem.

After the two (2) years the Supreme Deputy will report to the ESGC if all necessary work has been completed to allow the JGC to continue for at least five (5) additional years.

(2) If the GGC jurisdiction has continued as a JGC for a-the five (5) year period, the Supreme Guardian, after advising with at least six (6) members of the Executive SGC, shall determine if the JGC Charter should be revoked or they be allowed to continue as a JGC.

(a) During the above-mentioned five (5) year period, the Supreme Guardian may return the GGC Charter if all requirements as outlined in SOP-GGC-12 have been met.

REASON FOR CHANGE:

After speaking with affected former GGC's and their Deputies, we found this 2-year period is crucial to the success of the newly formed JGC/JB. It also ensures no premature charter removals which allows the Jurisdiction to move with ease and less worry during the rebuilding phase.

 - (1) Promote, in conformity with Supreme law, the organization of a GGC in jurisdictions when qualified.
 - (2) Institute Bethels when requested to do so by the Supreme Guardian.
 - (3) Ensure that members of JGC are installed in accordance with the Constitution and Bylaws of the Order, the Manual of Rules and Regulations and Books of Ceremonies of Supreme/Jurisdiction and the Bylaws of the Bethel.
 - (4) Ensure that members of BGCs are installed in accordance with the Constitution and Bylaws of the Order, the Manual of Rules and Regulations and Books of Ceremonies of Supreme/Jurisdiction and the Bylaws of the Bethel.
 - (5) Instruct Bethels after institution.
 - (6) Present Charters.
 - (7) Inspect the minutes of the JGC meetings, JGC books, records, and Annual Reports immediately prior to the official visit of the Supreme Guardian. Sufficient time shall be allocated for the inspection so that guidance and assistance may be rendered, and correction made if necessary. After being satisfied that the books are in order, the Supreme Deputy or Assisting Supreme Deputy, shall sign attesting to their condition. The results of the inspection shall be presented to the Supreme Guardian during the official visit.
 - (8) Review the reports of the Jurisdictional Guardian's inspection of each Bethel's books in the jurisdiction.
- (b) Serve as resource for the Jurisdictional Guardian Council, especially the Jurisdictional Guardian and Jurisdictional Secretary in the performance of their duties.
- (c) Work with the Jurisdictional Guardian to grant special dispensations.
- (d) Supreme Deputies shall report on their activities and the condition of Bethels under their supervision. Such reports shall be made within thirty days (30) of visitation.
 - (1) A copy of the expense report shall be sent to the Chairman of the Finance Committee.
 - (2) Copies of both reports shall be sent to the Supreme Guardian, Associate Supreme Guardian, Vice Supreme Guardian, Supreme Guide and Supreme Marshal.
 - (3) A report shall be made by November 1st and May 1st to those listed in paragraph (2) above if no visitation has been made.
- (e) Assisting Supreme Deputies shall report on their activities in the same manner as described in (d) above, sending said report to the Supreme Deputy on October 1st and April 1st.
- (f) When Assisting Supreme Deputies have assumed the duties of Supreme Deputies, they shall forward the

reports to those listed in (d) above.

SOP-SGC-1 APPEALS AND GRIEVANCES

Section 1. General

(a) Introduction.

(1) Discipline of all types should be considered very carefully as the outcome and consequences will affect Daughters, adults, Bethels, Jurisdictional Guardian Councils, Grand Guardian Councils, the Supreme Guardian Council, and all those who become aware of the action.

(b) General Information

(1) The purpose of our Order is to teach. It is vital that conflicts be resolved with fairness and justice, making disciplinary action a last effort, used only after all other methods have failed.

(2) A Bethel Guardian, Grand Guardian, or the Supreme Guardian shall not delegate to anyone the responsibility of handling a grievance. However, the Supreme Guardian may appoint a Special Deputy to conduct an investigation for her.

(3) A complete investigation shall be made for each grievance received. In all matters, the following steps shall be included in the process:

[a] Discussion with the person(s) filing the grievance.

[b] Discussion with the person(s) the grievance is filed against.

[c] Discussion with any other individual(s) named in the grievance.

[d] Consideration of all statements given by those individuals interviewed should be given in the determination of resolution of the grievance.

(4) The right to appeal is lost if not initiated within sixty (60) days after the date of action or decision on the grievance.

(5) The decision of the Executive GGC or the Executive SGC is final. In the case of a tie, this final decision shall go to the SGC Appeals and Grievance Committee to determine the final decision.

(6) Appeals and Grievances and action on same are not reported to or acted upon at any Annual Session of a GGC or the SGC.

(7) Where charges are preferred, or complaints made, such charges or complaints shall not be accepted unless they are specifically set forth in writing and signed by the person making the charges or complaints.

(8) Charges or complaints complying with item 7 above shall be investigated by a Bethel Guardian, Grand Guardian or the Supreme Guardian within thirty (30) days after she receives same. She shall expend her best efforts to adjust and settle the matter without necessity of further procedures.

Section 2. Specific Procedures

(a) If a Bethel Member or Bethel/Jurisdictional/Grand/Supreme Guardian Council Member feels her/his rights have been abused, she/he may file a written grievance provided they fit into one (1) of the seven (7) categories listed below:

Category 1: Bethel Member(s) vs. Executive Member(s) of Bethel Guardian Council

(a) The Bethel Member(s) shall file a written grievance with the Supreme/Grand Guardian

Category 2: Bethel Guardian Council Member(s) vs. another Bethel Guardian Council Member(s)

(a) The Bethel Guardian Council Member(s) shall file a written grievance with the Supreme/Grand Guardian.

Category 3: Bethel Member(s) or Bethel Guardian Council Member(s) vs. Supreme/Grand Guardian

- (a) The aggrieved person(s) shall file a written grievance with the Appeals and Grievances Committee of the Supreme/Grand Guardian Council.

Category 4: Jurisdictional Guardian Council Member(s) vs. another Jurisdictional Guardian Council Member(s).

- (a) The Jurisdictional Guardian Council Member(s) shall file a written grievance with the Supreme Guardian.

Category 5: Grand Guardian Council Member(s) vs. another Grand Guardian Council Member(s)

- (a) The Grand Guardian Council Member(s) shall file a written grievance with the Supreme/Grand Guardian.

Category 6: Supreme Guardian Council Member(s) vs. Executive Member(s) of Grand Guardian Council

- (a) The Supreme Guardian Council Member(s) will file a written grievance with the Supreme Guardian.

Category 7: Supreme Guardian Council Member(s) vs. Another Supreme Guardian Council Member(s)

- (a) The Supreme Guardian Council Member(s) will file a written grievance with the Appeals and Grievance Committee of the SGC

Section 3. Specific Procedures (Categories 1, 2, 4, 5 & 6):

In addition to the Officer specified in the above Categories, the aggrieved person(s) will send a copy of the grievance to the member(s) against whom the charges have been filed, stating specifically the nature of the alleged offense.

(a) Investigation of Grievance

- (1) In Categories where the grievance is filed with the Grand Guardian, the Grand Guardian shall investigate and render her written decision to the member(s) involved within thirty (30) days after the receipt of the grievance.

- (2) In Categories where the grievance is filed with the Supreme Guardian, the Supreme Guardian or Special Deputy appointed by the Supreme Guardian, shall investigate and render her written decision to the member(s) involved within thirty (30) days after the receipt of the grievance.

(b) If the decision of the Supreme/Grand Guardian is considered unsatisfactory, or the Supreme/Grand Guardian fails to act within the prescribed period, an appeal may be sent to the Chairman of the Appeals and Grievances Committee of the Supreme/Grand Guardian Council within sixty (60) days after the receipt of the decision of the Supreme/Grand Guardian or her failure to act on the grievance.

The Bethel member(s) or Bethel/Grand/Supreme Guardian Council Member(s) shall:

- (1) prepare at least six (6) copies of the appeal, including the decision of the Supreme/Grand Guardian;
- (2) send three (3) copies to the Chairman, Appeals and Grievances Committee of the SGC/GGC;
- (3) send one (1) copy to the Supreme/Grand Guardian;
- (4) send one (1) copy to the Executive Manager/ Grand Secretary;
- (5) send one (1) copy to each member against whom the charge has been filed.

(c) The Appeals and Grievances Committee shall investigate and render its written recommendation to the Executive SGC/GGC within sixty (60) days after receipt of the appeal. Such recommendation shall be sent to the Executive Manager/Grand Secretary.

(d) The Executive SGC/GGC shall meet within thirty (30) days, in person, by conference call, or via electronic mail to vote to uphold or deny the recommendation of that committee. A majority vote of the members of the Executive SGC/GGC shall be necessary to make a final decision.

(e) Within ten (10) days the written decision shall be sent by the Executive Manager/Grand Secretary to the member(s) involved.

(f) The decision of the Executive GGC or the Executive SGC is final. In the case of a tie, this final decision shall go to the SGC Appeals and Grievance Committee to determine the final decision.

Section 4. Specific Procedures (Category 3):

- (a) In addition to the Appeals and Grievances Committee of the SGC/GGC specified in Category 3 above, the aggrieved person(s), other than a Bethel Member, will send a copy of the grievance to the

member(s) against whom the charges have been filed, stating specifically the nature of the alleged offense. The aggrieved person shall:

- (1) prepare at least five (5) copies of the grievance;
- (2) send three (3) copies to the Chairman of the Appeals and Grievances Committee of the SGC/GGC
- (3) send one (1) copy to the Supreme/Grand Guardian
- (4) send one (1) copy to the Executive Manager/Grand Secretary

(b) If the aggrieved is a Bethel Member, she shall:

- (1) prepare five (5) copies of the grievance specifically stating the nature of the alleged offense
- (2) send four (4) copies to the Chairman of the Appeals and Grievances Committee, who shall send a copy of the grievance to the Supreme/Grand Guardian against whom the charges have been filed
- (3) send one (1) copy to the Executive Manager/Grand Secretary

(c) Investigation of Grievance

- (1) The Appeals and Grievances Committee of the SGC/GGC shall investigate and render its written recommendation to the Executive SGC/GGC within thirty (30) days after receipt of the grievance. Such recommendation shall be sent to the Executive Manager/Grand Secretary.
- (2) The Executive SGC/GGC shall meet within thirty (30) days in person, by conference call, or via electronic mail to vote to uphold or deny the recommendation of that Committee. A majority vote of the Executive Members shall be necessary to make a final decision.
- (3) Within ten (10) days the written decision shall be sent by the Executive Manager/ Grand Secretary to the members involved.
- (4) The decision of the Executive SGC/ GGC is final.

Section 5. Specific Procedures (Category 7)

(a) In addition to the Appeals and Grievances Committee of the SGC specified in Category 7 above, the aggrieved person(s) will send a copy of the grievance to the member(s) against whom the charges have been filed, stating specifically the nature of the alleged offense. The aggrieved person shall:

- (1) prepare at least five (5) copies of the grievance;
- (2) send three (3) copies to the chairman of the Appeals and Grievances Committee of the SGC
- (3) send one (1) copy to the Executive Manager

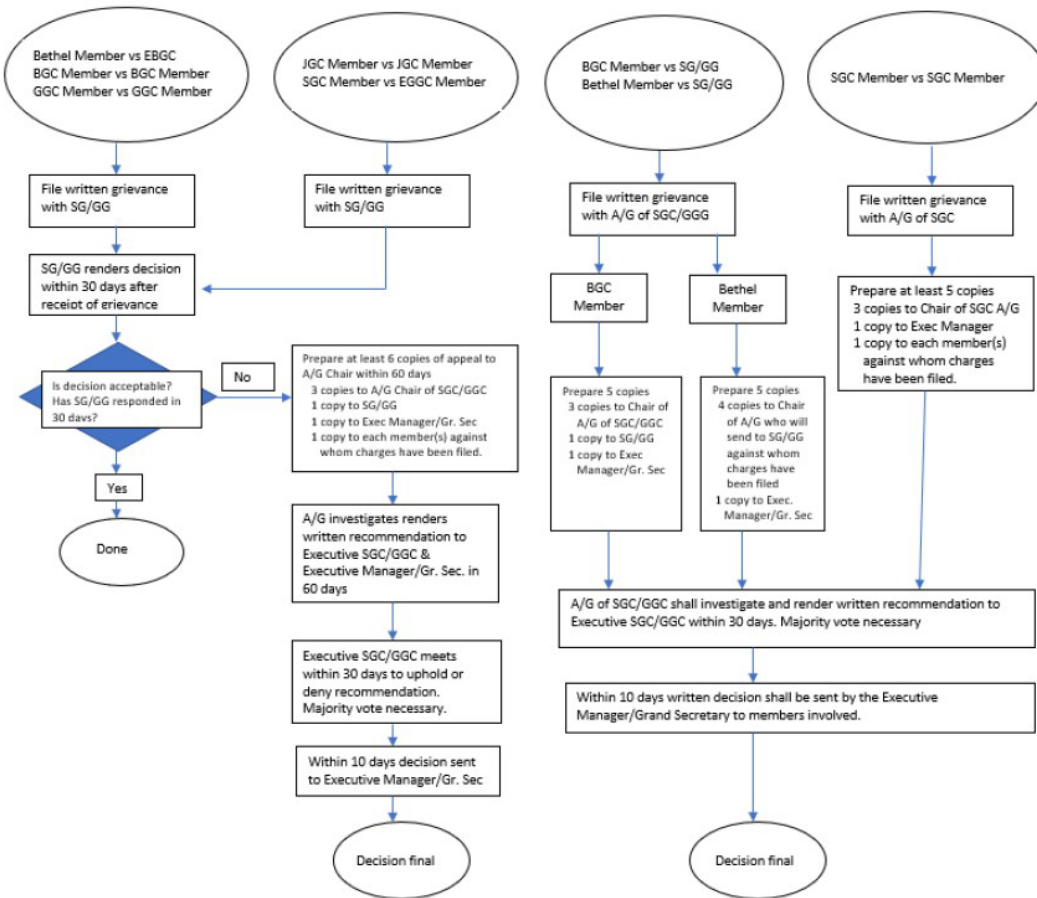
(b) The Appeals and Grievances Committee of the SGC shall investigate and render its written recommendation to the Executive SGC within thirty (30) days after receipt of the grievance. Such recommendation shall be sent to the Executive Manager.

(c) The Executive SGC shall meet within thirty (30) days in person, by conference call, or via electronic mail to vote to uphold or deny the recommendation of that Committee. A majority vote of the Executive Members shall be necessary to make a final decision.

(d) Within ten (10) days the written decision shall be sent by the Executive Manager to the members involved.

(e) The decision of the Executive SGC is final.

Section 1. Purpose

- (a) The purpose of our Order is to teach, and conflicts can be resolved with fairness and justice. This procedure ensures the fair, ethical, and consistent handling of grievances when bylaws, rules, or the Code of Conduct are alleged to have been violated. This process protects youth and adults, preserves organizational integrity, teaches conflict resolution, and maintains trust at all levels of Job’s Daughters International.
- (b) Disciplinary action shall be a last effort and used only after reasonable efforts toward education, reconciliation, and resolution have been made whenever appropriate.
- (c) All Appeals and Grievances procedures shall adhere to the following principles:
 - (1) Transparency – Parties shall be informed of timelines, steps, expectations, and outcomes.

- (2) Neutrality – Investigations shall focus on facts, not personalities.
- (3) Confidentiality – Privacy of all involved shall be protected.
- (4) Documentation – Written records shall be maintained at every step.
- (5) Education – Outcomes should include learning opportunities to prevent future conflicts.
- (d) Any committee member with a conflict of interest, bias, or personal association shall recuse themselves. The same standards of recusal shall apply at all levels, including BGC, GGC, and SGC.

Section 2. Filing a Grievance – Phase 1 (Days 0–14)

- (a) Any Bethel member, parent or legal guardian, certified adult volunteer, or Council member who has a legitimate concern that bylaws, procedures, or the Code of Conduct were violated may file a grievance.
- (b) All grievances must:
 - (1) Be written, specific, and signed (electronic signatures are acceptable).
 - (2) Be submitted electronically by email to the appropriate authority listed below. A written letter containing the required information shall be sufficient.
 - (a) Names and contact information of all individuals involved.
 - (b) Specific Code of Conduct, bylaw, rule, or procedure allegedly violated.
 - (c) Factual description (who, what, when, where, why, how).
 - (d) Supporting evidence (emails, texts, photos, videos, etc., uploaded in PDF format when possible).
 - (e) Date of submission.
 - (f) Two-week availability for interview scheduling.
- (c) Categories of Filing
 - (1) Category A – Bethels Under Supreme and Jurisdictional Guardian Councils: The grievance is filed with the Supreme Guardian, who may appoint the Supreme Deputy to investigate, with an emailed copy to Respondent and Executive Manager, and includes:
 - (a) Youth vs. Youth
 - (b) Youth vs. BGC Member
 - (c) Parent/Legal Guardian vs. BGC Member
 - (d) BGC Member vs. BGC Member
 - (2) Category B – Bethels Under Grand Guardian Councils: The grievance is filed with the Grand Guardian, with an emailed copy to Respondent and Grand Secretary, and includes:
 - (a) Youth vs. Youth
 - (b) Youth vs. BGC Member
 - (c) Parent/Legal Guardian vs. BGC Member
 - (d) BGC Member vs. BGC Member
 - (3) Category C – Grand Guardian Councils: The grievance is filed with the GGC Appeals & Grievances Committee with an emailed copy to Respondent and Grand Secretary, and includes:
 - (a) Any grievance against the Grand Guardian by Youth or Parent/Legal Guardian
 - (b) Youth vs. GGC Member
 - (c) GGC Member vs. GGC Member

If an Executive Grand Guardian Council member is the subject of the grievance, they shall recuse themselves from discussion and decision-making after a report is made by the GGC Appeals & Grievances Committee.

- (4) Category D – Supreme Guardian Council: The grievance is filed directly with the SGC Appeals & Grievances Committee, with an emailed copy to the Respondent and Executive Manager, and includes:
- (a) Any grievance against the Supreme Guardian by Youth or Parent/Legal Guardian
 - (b) Youth vs. SGC Member
 - (c) SGC Member vs. SGC Member

If an Executive Supreme Guardian Council member is the subject of the grievance, they shall recuse themselves from discussion and decision-making after a report is made by the SGC Appeals & Grievances Committee.

- (d) Within seven (7) days of receipt of emailed grievance, written acknowledgment shall be sent confirming receipt and outlining next steps.

Section 3. Investigation – Phase 2 (Days 15–45)

- (a) The goal of the investigation is to gather facts impartially, completely, and confidentially. The lead investigator shall be:
- (1) The Supreme Guardian, or the Supreme Deputy as appointed by the Supreme Guardian (Category A)
 - (2) The Grand Guardian (Category B)
 - (3) The appropriate Grand or Supreme Appeals & Grievances Committee (Category C and D)
- (b) The required steps to investigate a grievance include:
- (1) Interview complainant.
 - (2) Interview respondent.
 - (3) Interview relevant witnesses.
 - (4) Review all evidence.
 - (5) Maintain confidential written records.
- (c) The investigation shall be completed within thirty (30) days of receipt of the grievance. The lead investigator shall prepare a written report with findings and recommendations no later than ten (10) days after the completion of the investigation. The total time for the investigative report submission to the Executive GGC or Executive SGC shall not exceed forty (40) days from receipt of the grievance.
- (d) A decision on the outcome shall be made by majority vote of the Executive GGC or Executive SGC and communicated in writing to the Filer and the Respondent no later than forty-five (45) days, from the receipt of the filed grievance, by the Grand Guardian or Supreme Guardian, with copies to the Executive Manager or Grand Secretary, as applicable.
- (e) If additional time is required for just cause, the lead investigator or Appeals & Grievances Committee Chair may request up to seven (7) additional days from the Supreme Guardian or Grand Guardian to conclude the investigation. Written notice of the approved extension shall be provided to the Filer and Respondent.

Section 4. Appeal – Phase 3 (Days 45–90)

(a) Grounds for Appeal:

- (1) If any party to the grievance disagrees with the decision communicated, or
- (2) If no decision was rendered within forty-five (45) days without an approved extension.

(b) The appeal must be filed within thirty (30) days of the original decision or failure to act.

(c) The appeal submission must include:

- (1) The original grievance
- (2) The original decision (or statement of no action)
- (3) Any additional evidence or documentation supporting the appeal.

(d) For Categories A and D, the appeal shall be sent electronically to the Supreme Appeals & Grievances Committee Chair, with copies to the Supreme Guardian, Executive Manager, and Respondent.

(e) For Categories B and C, the appeal shall be sent electronically to the Grand Appeals & Grievances Committee Chair, with copies to the Grand Guardian, Grand Secretary, and Respondent.

(f) The Grand/Supreme Appeals & Grievances Committee shall review and submit a written recommendation to the Executive GGC/SGC for final decision no later than fifteen (15) days from the receipt of the appeal submission.

Section 5. Appeal Decision – Phase 4 (Days 90-105)

(a) The Executive GGC/SGC shall meet within ten (10) days of receiving a Grand/Supreme Appeals & Grievances Committee recommendation.

(b) A majority vote is required to accept the appeal and overturn the decision.

- (1) In the event of a tie, the matter shall return to the Appeals & Grievances Committee for final determination.

(d) A final written decision of the outcome on the appeal shall be issued within five (5) days of the majority vote.

(e) The decision is final. No further appeals shall be permitted.

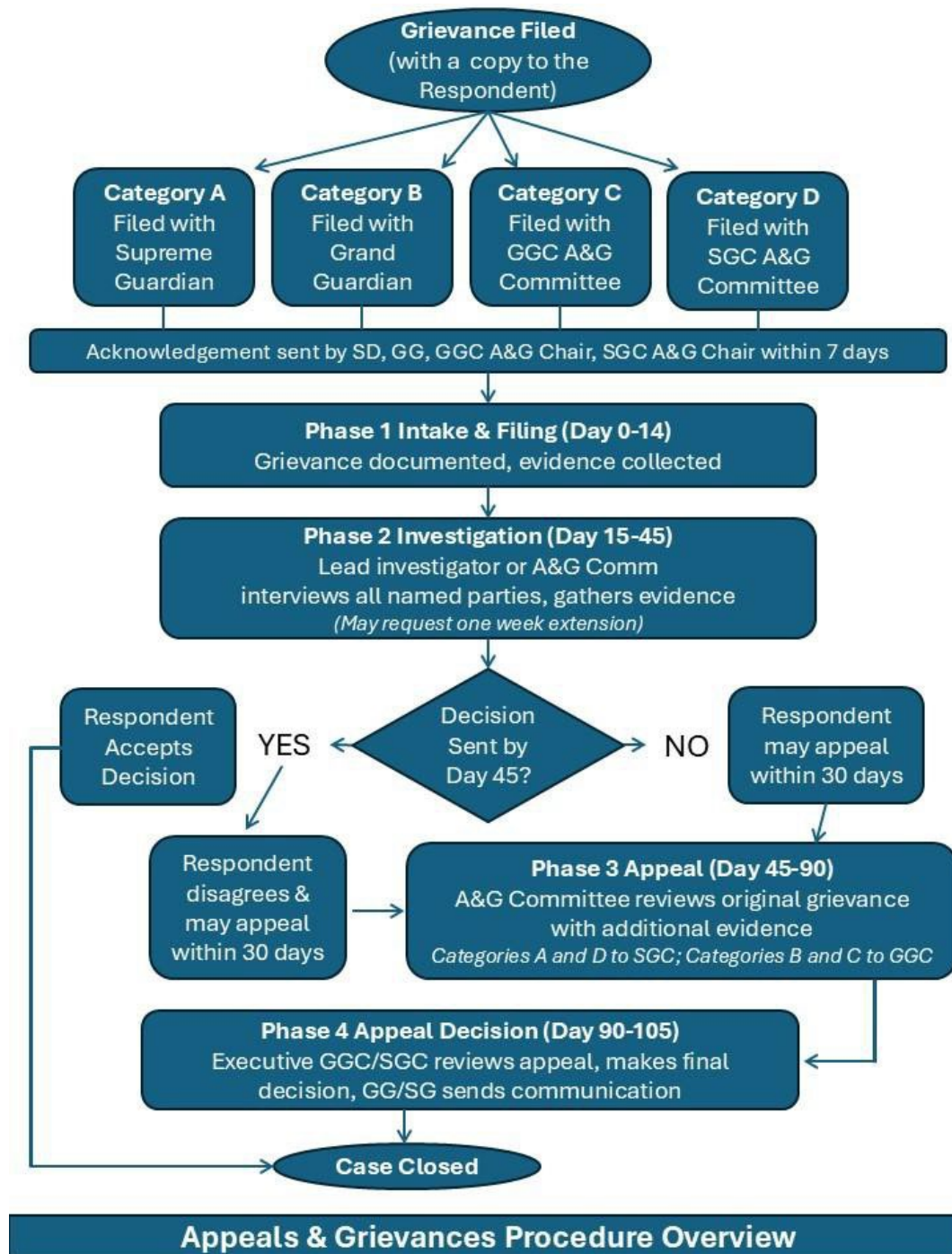
Section 6. General Provisions

(a) All appeals and grievances must be in writing, sent through email, and include all parties, as outlined in this procedure.

(b) Appeals and Grievances shall not be reported or acted upon at any Annual Session.

(c) The right to appeal is lost if not initiated within 30 (days) of the original decision or failure to act.

(d) All records at every phase shall be maintained confidentially in accordance with organizational policy and retained by the Executive Manager or Grand Secretary, as applicable, to ensure complete recordkeeping.




REASON FOR CHANGE:

- (j) "Business" Meetings (business professional attire) with the approval of the EBGC, Bethel Members may vote to wear attire other than the official regalia (1 meeting a month) with the vote cast at a previous meeting. Meetings shall be conducted in conformity with Robert's Rules of Order Revised (latest edition).

 - (2) No more than 1 per month and 4 (or 5) per term

 - (2) The "Business" Meeting is an optional meeting format **for Bethels not under reorganization;**
 - (3) Shall be conducted in conformity with the laws of the SGC and Robert's Rules of Order Revised (latest edition);
 - (4) There shall be no more than (2) two Business Meetings per 6 month term.
- (l) The specific business attire to be worn by members for an Informal Meeting or Business Meeting shall be reviewed and approved by the BGC, who shall ensure it aligns with organizational values, promotes equality among members, and is appropriate for the jurisdiction's climate and cultural context.
- (m) The Bethel shall exemplify the Membership Ceremony at least one (1) time each term. If no candidate is available, a previously initiated Job's Daughter shall be used.

(n) The Bethel shall perform the Majority Ceremony and/or the Obligation Ceremony at a regular (or special) meeting one (1) time during the year.

REASON FOR CHANGE:

This amendment is not about removing the robe, but about preserving what it represents. The robe has always been a symbol of equality — a reminder that within this organization, all members stand on equal ground. By reserving the robe for designated ceremonies, we elevate its meaning and continue to honor that shared identity at our most significant moments.

In the same spirit, permitting business attire for Informal Meetings and Business Meetings, establishes a **professional meeting uniform** that affirms our commitment to developing confident, capable leaders. Dressing professionally teaches young women how to present themselves with pride, purpose, and readiness for the real world — a core value of this organization. **Job’s Daughters of today will be the leaders in boardrooms of tomorrow.** This will give them the opportunity to learn how to run meetings in the style of an executive boardroom. This professional meeting uniform will be approved by each BGC, ensuring consistency, appropriateness, and alignment with local needs while maintaining equality across the organization.

THIS DOES NOT MEAN THAT BETHEL HAVE TO HOLD INFORMAL OR BUSINESS MEETINGS, it simply gives them the option to do so. It provides the opportunity for Bethels to operate successfully within the cultural context of their Jurisdictions.

“Business meetings” being not so time consuming, can be especially helpful when activities, charity events, or ceremonies are scheduled on the same day, giving members more time to focus on these important events. The robe remains the standard for ceremonies, and this flexibility allows Bethels to make decisions that best support their members’ comfort, engagement, and leadership development.

As our organization grows across diverse regions, we must consider the realities our members face. In hot climates, girls have raised concerns that the robe can be uncomfortable as they feel hot & sweaty and this affects their engagement and sometimes their attendance. Allowing a professional meeting uniform shows care for members’ well-being while keeping them fully involved.

This amendment reflects thoughtful stewardship of our traditions and values. It is not a departure from who we are, but a respectful evolution — one that honors our legacy of equality while preparing our girls for the future they are being called to lead. **NOT** allowing this change is not inclusive and dismissive of non-American cultures.

If this amendment is passed, the current bylaw items **k** and **l** will need to be renumbered as **m** and **n** to reflect the changes made. This should fall under housekeeping.

REASON FOR CHANGE:

The proposed change to increase the minimum age requirement for the Royal Purple Degree from twenty-five (25) to thirty (30) years is based on current scientific and social research regarding human development. Contemporary studies in the fields of psychology and neuroscience indicate that the transition into full adulthood occurs later than previously understood, with the period traditionally identified as adolescence and emerging adulthood extending into the late twenties. This adjustment reflects a broader and more modern understanding of emotional maturity, identity formation, long-term responsibility, and life stability, all of which are consistent with the dignity, symbolism, and expectations associated with the Royal Purple Degree. By establishing the minimum age at thirty (30), the Order affirms that this Honor is conferred at a stage of life in which recipients have had sufficient time to develop sustained leadership, service, personal growth, and a continued relationship with the teachings and values of Job’s Daughters International beyond their active years. In addition, it is essential that this recognition be connected to active and meaningful service. Requiring that nominees be currently engaged in the work of a Bethel helps ensure that the Degree is not conferred in an isolated or merely honorary manner, but rather as a reflection of ongoing commitment, mentorship, and support for the members. This strengthens the living relationship between Majority Members and the Bethels, preserves the purpose of the Honor, and promotes consistency and fairness in its administration. This proposal does not diminish the accomplishments of those who are younger; rather, it elevates the meaning of the Degree, aligns it with current knowledge about adult development, and helps ensure a more uniform standard of readiness and life experience among its recipients throughout all Jurisdictions.





REASON FOR CHANGE:

The purpose of this amendment is to provide a framework through which the Supreme Honors may be administered in a manner that is, at a minimum, consistent and equitable throughout all Jurisdictions. By allowing Jurisdictions to adopt and adapt the official Rules and Regulations, as published by the Supreme Guardian Council and without alteration, the integrity of the Honors is preserved while also making their implementation accessible worldwide.

This measure seeks to eliminate disparities in understanding, eligibility, and administration that may arise from the absence of clear authorization for local adaptation. At the same time, it ensures that the standards established by the Supreme Guardian Council remain unchanged and universally respected.

The amendment therefore supports the global unity of the Order, promotes fairness in recognition, and affirms that Supreme Honors should be considered and conferred under substantially equal conditions in every part of the world.





**ARTICLE IV
MEMBERSHIP**

Section 1. Members

(a) Girls between the ages of ten (10) and twenty (20) years who bear a Masonic relationship shall be eligible for membership. Masonic relationship shall be interpreted to mean a relationship by blood, marriage, or law to a:

- (1) Mason (See POL-BOT-2),
- (2) his wife or widow,
- (3) a member of Job's Daughters,
- (4) or a Majority Member of Job's Daughters.

(b) If, after diligent and exhaustive search, Masonic relationship cannot be verified for an Applicant, a Majority Member and a Master Mason (other than the Bethel Guardian or Associate Bethel Guardian) may sponsor the Applicant.

(c) A woman under the age of twenty (20) years who has been married, divorced, whose marriage has been annulled or who is pregnant, or has ever been pregnant, except in the case of rape (or its equivalent terminology) or incest is not eligible for membership.

(c) In the case where the Grand Lodge of the Jurisdiction does not recognize Job's Daughters and denies support to Job's Daughters by Masons within the Jurisdiction. the applicant may be sponsored by two Majority Members of the Bethel (other than the Bethel Guardian and Associate Bethel Guardian).

REASON FOR CHANGE:

In a Jurisdiction where a Master Mason could lose his Masonic membership by supporting Job's Daughters, by decree of the Grand Lodge, no Mason will sign an application for membership. Although a sponsorship could be given by a Master Mason from another jurisdiction, this does not make sense since that Master Mason probably would not know the applicant. When the Bethel is not supported by the Masons, we need to be in control of our own membership.
